Willem van Genugten is Emeritus Professor of International Law at Tilburg University.

His alma mater is Radboud University in Nijmegen, where he studied both law and philosophy and defended his PhD thesis. He has been a.o. professor at the Minnesota School of Law, USA, cofounder and chair of the Center for Transboundary Legal Development at Tilburg University, Dean of the Tilburg Law Faculty (twice), chair of the board of the National Research School Human Rights, chair of the board of NWO-WOTRO Science for Global Development and the editor/editor-in-chief of the Netherlands Yearbook of International Law. From 1991 until 2012, he held several policy advice positions for the Dutch government, a.o. as chair of the standing Commission on Human Rights of the Advisory Council of International Affairs.

He has published on a series of international law subjects, both in the classical legal sense and from a multi/interdisciplinary perspective, with a special focus on human rights and economic actors and factors. So far, he supervised 37 PhD candidates on their way to the auditorium. In 2012, he was awarded a doctorate honoris causa by North-West University, South Africa for his "international legal stature" and his "passion for promoting international scholarly relations".

Marleen Janssen Groesbeek is lector Sustainable Finance and Accounting at the Avans University of Applied Sciences, located in the cities Breda, Roosendaal, 's-Hertogenbosch and Tilburg.

Prior to working as a lector, she worked as a financial journalist for almost 20 years, primarily for the Dutch newspaper *Het Financieel Dagblad*. After her carrier as a journalist she worked for a couple of years as a Sustainability Advisor at Eumedion, the organisation representing the interests of institutional investors active in the Netherlands. Subsequently she was Sustainability Manager at DSM, focussing on stakeholder engagement and integral reporting. Her first book, *Maatschappelijk Ondernemen*, was published in 2001 and since then she has published books and articles about sustainability, creativity and leadership on a regular basis. She has is member of *Het Groene Brein*, Sustainable Finance Lab and works as a columnist at the magazine P+, and has several additional positions, among others at CE Delft, ASN Bank, Rank-a-Brand, *Fossiel Vrij Nederland* and the *Pieter Hennipman stichting*.

The slogan of her lecorate is *Change finance, finance change*. In her inaugural speech she emphasized that achieving a sustainable monetary and financial system requires us to take action ourselves. She studied economics at the University of Amsterdam.

David Kovick is Senior Advisor at Shift, a non-profit organisation specialized in business and human rights, based in New York City.

At Shift, he oversees all the facilitation and dialogue processes, making sure that the organisation's engagements are driven by participants' needs, are interactive and have a lasting impact on participants' thinking and decision making. As a mediation and dispute resolution expert, he particularly focuses on facilitating multistakeholder dialogue and cross-cultural collaborations. With Shift, he has facilitated dialogue and led capacity building with companies, governments, financial institutions and civil society organizations in Africa, the Americas and Europe.

Prior to joining Shift, he contributed to the work of the Special Representative of the UN Secretary-General for business and human rights John Ruggie, specifically advising on the role of mediation and dispute resolution tools as part of the Access to Remedy pillar of the Guiding Principles. He conducted this work as part of his role with the Consensus Building Institute (CBI), an affiliate organization of the Harvard/MIT Program on Negotiation. While with CBI, he worked as both a neutral third party, designing and leading stakeholder negotiations in some of the most challenging parts of the world, and as a trainer, advisor and coach to leaders of Fortune 50 companies in the extractive, high tech and pharmaceutical industries

He earned his law degree from Stanford Law School and his Bachelor of Arts in Political Science and African Studies from Duke University. Prior to his work as a mediator, he worked in Zimbabwe and other regions of southern Africa and in Southeast Asia, supporting democratic governance and electoral reforms.
